



## SAMARCO AND ANCHIETA'S CITY HALL INAUGURATE CITIZEN'S HOUSE

*The mining company invested around R\$ 3 million in the construction of the space, which will offer various services to the city's and neighboring municipalities' populations.*

Samarco, in conjunction with the Anchieta City Hall, opened on Friday (29), the Citizen's House. At the site, residents of Anchieta and neighboring municipalities may perform various services such as request their identity card or social security number's duplicate and also obtain information regarding their own businesses. In addition, tourists will also be able to ask for information about the region at the Citizen's House.

Investing in the citizenship area was one of the priorities set out in the Socio-environmental Commitment Term (TCSA) signed between Samarco, the state government of Espírito Santo, the Public Prosecutor's Office of Espírito Santo, the municipalities of Anchieta, Guarapari, and Piuma, with the technical intervention of the State Institute for the Environment and Water Resources (IEMA).

The inauguration ceremony settles the TCSA, which included other infrastructure projects in municipalities neighboring the company's operation areas focusing on health and citizenship. Within the same Term, for example, paving works were delivered in Guarapari, in the Porto Grande neighborhood and it was also delivered the Maria Lúcia de Almeida Cunha Lora Family Health Unit. In Piuma, the renovations of the Municipal Hospital Nossa Senhora da Conceição were initiated.

All projects have been defined by the signatories of the TCSA that have representatives on a committee set up to discuss and decide on the investments carried out by Samarco. "The Citizen's House shows, in a practical way, the positive potential that lies in the partnership between civil society, public institutions and the company", says Roberto Carvalho, Samarco's CEO.

Responsible for executing the work, Samarco invested around R\$ 3 million in the project. In the Term, it is under the responsibility of Anchieta's City Hall to deliver the equipment and manage the space, as well as the team that will compose the administrative and maintenance structure.

"Our focus is to provide quality and efficient assistance, making the lives of the Anchieta and neighboring towns' citizens easier. The provision of services in one place will give agility to business people and future entrepreneurs, enabling the diversification of activities in our municipality. We are working and we thank Samarco for the partnership to build the Citizen's House", said the mayor of Anchieta, Marcus Assad.

### TCSA

The Socio-environmental Commitment Term (TCSA), signed at the time of construction of Samarco's fourth pelletizing plant, has as a premise shared and co-responsible action

between the company, the state government, the Public Prosecutor's Office of Espírito Santo and the municipalities of Anchieta, Guarapari and Piuma, with the technical intervention of the Institute for the Environment and Water Resources (IEMA), aiming at the enhancement of the development of the area under direct influence of Samarco's industrial plant in Ubu, Anchieta.

The Term has given rise to a pioneering governance model structured to meet commitments made with the cooperation of multiple actors - public and private - in order to promote the areas' development strategies.

Anchieta, Guarapari and Piuma received investments of around R\$ 12.2 million as part of Samarco's Investment Plan funds. With this amount, the company contributed to the socioeconomic development of the three municipalities, especially with regard to health, citizenship and infrastructure.

Of this total, about eight million Reais were invested in projects approved by the TCSA's Management and Monitoring Commission.
